Invitation for Bids for the Barbote (Mid Hill Highway), Ewa to Dhaude Bazar Road

1. The Government of Nepal [GoN] **has allocated funds** from **GoN** towards the cost of Barbote (Mid Hill Highway), Ewa to Dhaude Bazar Road and intends to apply part of the funds to cover eligible payments under the Contract **for** Barbote (Mid Hill Highway), Ewa to Dhaude Bazar Road **and** NCB/ARM/ROAD/02/078/079. Bidding is open to all eligible as per Section V of bidding document.
2. **Aathrai Rural Municipality** invites electronic bids from eligible bidders for the Barbote (Mid Hill Highway), Ewa to Dhaude Bazar Road under National Competitive Bidding – Single Stage Two Envelope Bidding procedures.

Only eligible bidders with the following key qualifications should participate in this bidding:

- Minimum Average Annual Construction Turnover of the best 3 years within the last 10 years: **NRs 80204015**
- Minimum Work experience of similar size and nature: one Contracts within the last five (5) years, each with a value of at least NRs 64163212
- 3. Under the Single Stage, Two Envelope Procedure, Bidders are required to submit simultaneously two separate sealed envelopes, one containing (i) the Technical Bid and the other (ii) the Price Bid, both in turn enclosed in one sealed envelope as per the provision of ITB 21 of the Bidding Document.

8. The bids will be opened in the presence of Bidders' representatives who choose to attend at **2079/02/10 ,2:00PM** at the office of **Aathrai Rural Municipality,Sankranti Bazar**. Bids must be valid for a period of **120 days** after bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid, amounting to a minimum of Nrs.2345500, which shall be valid for 30 days beyond the validity period of the bid.
9. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
10. Acceptance, partially acceptance and rejection of bid shall be the right of Aathrai Rural Municipality.
